I have read and understand the following:

1. I understand that I am solely responsible for any harm caused by my pet(s) while my pet(s) is attending The Fur Institute for any service available.
2. I further understand and agree that in admitting my pet(s) to The Fur Institute that all the staff at The Fur Institute have relied on my representation that my pet(s) is/are in good health and have not harmed or shown aggressive or threatening behavior toward any person or animal. I have also supplied the telephone number of my vet who can verify that my animal's vaccinations are current.
3. I further understand and agree that The Fur Institute and their staff and volunteers will not be liable for any problems or injuries which may develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my pet(s) attendance and participation at The Fur Institute.
4. I further understand and agree that any problems which develop with my pet(s) will be treated as deemed best by staff and volunteers of The Fur Institute, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved. The staff and volunteers at The Fur Institute are required to make every effort to contact me via the telephone numbers I have provided prior to or during any emergency medical treatment.
5. I also understand that The Fur Institute is a licensed vocational professional pet styling program. I have elected to have a grooming student groom my pet and my pet will be part of the educational process. During the grooming process, my pet may be photographed or videotaped as part of the student's portfolio of work. Grooming students are always under the supervision of experienced grooming instructors. Feline grooming will not be performed without the supervision of a feline grooming instructor under any circumstances.
6. The Fur Institute considers major matting & pelt removal to be a health risk to your pet. If your pet requires major matting & pelt removal from its coat, there will be an additional charge. In addition, major matting & pelt removal is extremely risky for your pet. You should be aware that your pet may suffer from razor burn, nicks, minor and/or major cuts, hematoma (bruising) to the skin, and/or serious injury or death as a result of removing major mats and/or pelts in their coat. If you choose to proceed with the removal when your pet's coat is in this condition, you do so at your own risk and expense for any veterinary care your pet requires after the grooming service.
7. The Fur Institute will not allow openly aggressive or vicious animals to be groomed by a grooming student for their own protection. If your pet is openly aggressive or vicious, we will happily refer you to a professional grooming salon that has groomers with the experience to groom your pet properly.
8. We close promptly each day at 5:00PM and expect your pet to be picked up prior to our closing time. If you are up to 30 minutes past this time, you will be charged \$25. If you are over 30 minutes late, you will be charged \$1 for each minute after 30 minutes.
